## **THIS NOTICE DESCRIBES HOW HEALTH INFORMATION ABOUT YOU MAY BE DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION.**

### **TLM Medical Services will follow this notice:**

This notice describes our privacy practices. All these entities, sites, and locations follow the terms of this notice. In addition, these entities, sites and locations may share health information with each other for treatment, payment or health care operations purposes described in this notice.

### **OUR PLEDGE REGARDING HEALTH INFORMATION:**

We understand that health information about you and your health care is personal. We are committed to protecting health information about you. We create a record of the care and services you receive from us. We need this record to provide you with quality care and to comply with certain legal requirements. This notice applies to all of the records of your care generated by this practice, whether made by your personal doctor or others working in this office. This notice will tell you about the ways in which we make use and disclose health information about you. We also describe your rights, the health information we keep about you, and describe certain obligations we have regarding the use and disclosure of your health information.

We are required by law to:

- **Give you this notice of our legal duties and privacy practices with respect to health information about you;**
- **Follow the terms of the notice that is currently in effect**

In addition, each time you register for treatment or health services, we will offer you a copy of the current notice in effect.

## **COMPLAINTS**

If you believe your privacy rights have been violated, you may file your complaint. To file a complaint with us, contact Tracie Jones, Office Manager. All complaints must be submitted in writing. You will not be penalized for filing a complaint.

## **OTHER USES OF HEALTH INFORMATION**

Other uses and disclosures of health information not covered by this notice or the laws that apply to us will be made only with your written permission. If you provide us permission to use or disclose health information about you, you may revoke that permission, in writing, at any time. If you revoke your permission, we will no longer use or disclose health information about you for the reasons covered by your written authorization. You understand that we are unable to take back any disclosures we have already made with your permission, and that we are required to retain our records of the care that we provided you.
